Updates to the claims and reimbursement forms

In an effort to update our forms and to be consistent, MRCI has updated the claims and reimbursement forms for the programs of CDCS and CSG.

Please note the largest change: receipts for reimbursements and invoices will be due within 60 days from the date of purchase/date of service. This change will allow MRCI to have better oversight of your budgets, this includes revisions to be made within a timely manner for the plan year.

MRCI has also created a separate form for credit card orders. This form is capable of being filled out on your computer which will allow you to copy and paste the URL (the detailed web address) for the items requested to be ordered directly into the form. A signature and date at the bottom are still required.
